
MANAGEMENT & AVOIDANCE OF CONFLICTS OF INTEREST

THROUGH CARE MINISTRY

IN-CARE (FOR INMATES)

70x7 helps the prison authority to conduct a part of their Gang Desistence programme where inmates are shown ways by which they can renounce their gang affiliation and turn over a new leaf.

AFTERCARE (FOR RELEASED MALE & FEMALE EX-OFFENDERS)

Aftercare activities commence at the prison gate on the day of an inmate's release. When requested by an inmate, he/she will be met by volunteers and/or staff at the time of his/her release ("Prison Gate"). The ex-offender will then be followed up through a journeying process which include support in the areas of skills upgrading, job placements and financial aid, etc. The objective of Aftercare is to journey with the ex-offender as he/she re-integrates into the society.

Activities funded in Aftercare include:

- Case management and referrals
- Job referrals and placements
- Skills upgrading talks/ workshops
- Bonding gatherings and birthday celebrations
- Financial and practical assistance

FAMILY CARE MINISTRY (FOR FAMILY MEMBERS OF INMATES AND EX-OFFENDERS)

We partner with churches, volunteers, and organisations to bring love and support to families of inmates to break the inter-generational cycle of offending. Through programmes designed to help the affected adults, youth and children, we hope to assist in the strengthening of the family units and providing an environment that is conducive for reconciliation of inmates and ex-offenders to their family members, and their eventual re-integration into society.

Practical support for inmates' families include medical visits, escorts to visit inmates in prison, social assistance referral and case management, financial aid, educational programmes for children, educational bursary and outings for children and family members.

Activities under Family Care include:

- Children and youth programmes
- Care Club (weekly children's programme with one-to-one tuition and group enrichment activities)
- School holiday programmes and outings
- Early Learning Programme numeracy and literacy programme for weaker students
- Educational psychologist assessment
- Counselling and therapy
- Educational sponsorship
- Financial assistance, groceries support, Milk and Diapers programme
- Family bonding events / outings
- Share God's love
- Events and celebrations
- Case management and referrals; family visits
- Volunteer outings/ retreat

Volunteers are our valuable partners. It is through constant engagement with them that we will eventually see a community that embraces inmates, ex-offenders and their families. We aim to continue to work on enhancing our care and equipping of volunteers through training and various engagement activities.

REVIEW AND EXPLANATION

REVIEW OF FINANCIAL STATE AND EXPLANATION OF MAJOR FINAN-CIAL TRANSACTIONS:

70x7 recorded a net surplus of \$220,714 for the financial year ended 31 December 2019. This is attributed mainly to donations raised through the Gala Dinner event (held in celebration of the 66th anniversary of prison ministry in Singapore), as well as receipt of Care & Share grant disbursement from NCSS (National Council of Social Service).

PASSENGER VAN

The passenger van (purchased in 2016) which is held in trust by PFS for the benefit of 70x7 was used mainly for:

- Ferrying
- ex-offenders and their family members to their home, halfway houses or for other purposes
- children of ex-offenders to and from home for Care Club, KayCan and other activities
- staff and volunteers for various activities
- Home visits and delivery of donated food or other items to beneficiaries
- Transport for festive celebrations, camps and other activities



70x7 intends to fund and manage more pro-social, non-religious work amongst those whose lives have been affected by crime. Some highlights are:

- Continue to support ex-offenders by equipping them with necessary skills, assist in job placements, and in meeting their social needs
- To enhance the Prison Gate programme to boost the number of ex-offenders who will consider joining the support group activities
- To plan new In-Care programmes that will reach more of the prison population
- To continue reaching out to the families of inmates through the Family Care Ministry
- Becoming more involved with other rehabilitative agencies and partners such as the CARE network
